This May, delegates from across Canada will come to Ottawa for ARPA Canada's biennial God & Government event. You are invited to join us for 2 full days of training, equipping, strategizing and lobbying. You will also have opportunity to tour Parliament and the Supreme Court, attend question period and sit in on various parliamentary committee meetings. In previous years, this was only open to those who were active members of a local ARPA chapter. The invitation to attend is now extended to all members of Reformed churches.

Joe Boot and most meals and hotel accommodations in downtown Ottawa – with the option of adding a 3rd night stay and participation in the Reformed Pro-Life Prayer Service and National March for Life. Electoral Reform

As part of their election promises the Liberal Party of Canada said "We are committed to ensuring that 2015 will be the last federal election conducted under the first-past-the-post voting system."

Since the election, the Liberal Government has set up a committee to assess the options for a new voting system. It seems the Liberal government is leaning towards a preferential ballot system.

The Opposition has challenged the government on this issue, arguing that the government is using the new electoral system for political gain and are using the power of a majority government to advance a position which should require a referendum. After all, Canadians have been using a first-past-the-post system since Confederation.

At this point, it is clear that to change the electoral system in Canada a referendum should be a minimum requirement. A referendum would require the general public to vote in all the provinces and territories on any new system and must get a large majority in order to pass.

Cassie & Molly's Law

MP Cathay Wagantall, along with Jeff Durham and the Molly Matters Campaign, have been working tirelessly to bring about a law that would amend the Criminal Code of Canada. Jeff is the father of Molly, a girl who was killed when she was still in her mother's womb. Molly and her mother, Cassandra, were killed in December 2014 but – although a suspect has been charged – there has only been one murder charge laid, that for Cassandra. Molly's death goes unacknowledged, even though she was only weeks away from being born.

The good news is, there has been some excellent progress in Parliament concerning pre-born children in Canada. On February 23, Saskatchewan MP Cathay Wagantall introduced Bill C-225 in the House of Commons. This bill, titled the *Protection of Pregnant Women and their Preborn Children Act* (the short title is *Cassie and Molly's Law*), will create a new offence for violent criminals who knowingly injure or cause the death of a pre-born child while committing a criminal offence against a pregnant woman.

The first step for Cassie and Molly's Law is that it needs to be approved for debate in the House of Commons. Our SimpleMail program on the WeNeedaLaw.ca website includes 3 letters on this issue and they can be accessed at simple.arpacanada.ca. It is necessary to speak up and ask your MP to vote in favour for this common-sense bill to become law. Once approved, the bill will likely be debated mid to late April. Please keep Mrs. Wagantall and Jeff Durham (Jeff is the father of Molly) in your thoughts and prayers that these efforts may prove fruitful and that we may see this law passed in the coming months! You can also print a copy of the Molly Matters petition from the <u>WeNeedaLaw.ca</u> website. Collect as many signatures as possible and mail it to the address that can be found on the bottom of the form. Each of these forms is brought into the House of Commons and when all those sitting in the House see how many signatures have been collected, it will be hard for them to deny the issue and ignore the thousands of Canadians who are willing to speak up.
